Colleagues, in just a moment I'll give our schedule for the day, but I did want to note that on this day in 1960, Dorothy Irene Height's first column, called "A Woman's Word", appeared on page 8 of the *New York Amsterdam News*. Dorothy was an educator, a civil rights and women's rights activist, specifically focused on the issues of African-American women. She was the President of the National Council of Negro Women for 40 years, and was awarded the Presidential Medal of Freedom in 1994, and the Congressional Gold Medal in 2004. We should remember all of her incredible works over the years.

And under the heading of "Did You Know," did you know that the *Twilight Zone* creator, Rod Serling, was born in Binghamton, New York, located in the 123rd Assembly District represented by our friend, Ms. Lupardo? Following his service in the U.S. Army during World War II, Serling received a Bachelor's degree and began writing for TV and radio. His Emmy Award-winning show first aired in 1959, with a handful of episodes drawing from his upbringing in Binghamton. I don't know what life was like in Binghamton in those days, but a little unusual, I'd say, if that's where he derived his inspiration.

But we are not in a twilight zone here, we're in the New York State Assembly, and let me give you a --

He's the Executive Secretary of the Home Mission Board of the National Baptists, and he's a member of the Baptist Conference of Greater New York and the vicinity.

Today I rise in remembrance of Mathilde Krim, the founding

Chairwoman of amfAR, the American Foundation for AIDS Research.

Mathilde Krim passed away on January 15th, 2018 at the age of 91 at her Kings Point home and left an immense legacy. After the first cases of AIDS were reported in 1981, Mathilde Krim recognized the grave consequences that this virus was having, and took the lead in research about its transmission and raising awareness. Her Ph.D. in Biology provided her the knowledge to become an indispensable part of the quest for some of the earliest HIV/AIDS treatments and therapies, and led to her being known as a scientist-turned-activist.

At the height of the AIDS crisis when many were turning their heads, Dr. Krim was on the front lines of this war trying to expand research efforts and mitigate the devastating impact that AIDS was having. She was fearless in her efforts and was quick to quell all the fears and misconceptions being spread about HIV and AIDS. It is in large part due to the efforts of Dr. Mathilde Krim that we have gained a better understanding of this virus and been able to diminish the stigma that is experienced by individuals affected by HIV and AIDS.

A true crusader in this battle, we owe her an immense debit -- sorry, an enormous debt of gratitude for her tireless dedication to all she helped accomplish and to all of the lives she helped save. Thank you.

And she was wonderful, she was supportive, she was kind. And she was very caring and opened her home repeatedly for various events in order to raise necessary funds, both for causes and for people. And she will, of course, be missed.
